A. A motion was made by Kelly Bailey and seconded by Eddie Ware to open the public hearing to consider applicants for the designation of the Community Action Agency for the Parish of Beauregard. No one opposed. Motion carried.

B. Consider applicants for the designation of the Community Action Agency for the Parish of Beauregard.

Mr. Lynell Wilson was introduced to speak on behalf of Beauregard Community Actions.

Lynell Wilson-Good evening everyone. I believe there was a question in regards to the designation of Community Action Agencies in any given parish. I would like to wait until there is any information so that we can have a chance to review it. I would like to understand what the question was as far as the designation of the Community Action Association in Beauregard Parish.

Mike Harper - It is my understanding that it was a routine thing to be reviewed every year and to have a report of the services that were provided for our parish by any agency that represents us. Then, to see if any other agency would like to represent us in the future.

Lynell Wilson - Well, you have the documentation in front of you now that Nation Partners Tax Law and legal partners with Community Action Services. My name is Lynell Wilson and I am formerly with the state office of LA. Right Now. I am the manager at ACAP, we had and call from one of our members with questions regarding designation, which it was already stated before that according to the LA RSV2363-17 seem to imply that the annual designation must be requested by the parish. That is no longer the law, as you can see in the revised part 2363-17, the Louisiana Work Force is the one that gives authorization to the agency to wear your patch. We wanted to make sure so we checked with our national partners, we checked with CAP law, it states that basically it is given to the Executive Officer, which in this case would be the Governor. The Governor then assigns a state agency to handle them. In this case, it would be the Louisiana Work Force Commission. They are the only arm to identify who will serve in the parish. They, in return authorize who does what. So, my question is there was a possibility of discussion on redesignating or identifying someone else or application of redesignation until the State of Louisiana says otherwise. The State of Louisiana does not do anything with the redesignation nor currently work with Beauregard Community Actions.

Mike Harper- So it is, in your opinion, that BPPJ has no authority to choose any agency to represent us?

Lynell Wilson- Those opinions where given in according to LA Revised Statutes, no you do not. That is the authority of the Louisiana Workforce Commission.

Mike Harper - Ok thank you very much, any question?

Bryan McReynolds - Asked who he was and who he was with?

Lynell Wilson - If you look at the CAP Law the very $1^{\rm st}$ page it identifies the question being asked.

Mike Harper- You are with CAP Law?

Lynell Wilson - I am with ACAP.

Mike Harper- My question is since BPPJ, in your opinion, has no authority over this agency, then it is a state agency. Is that correct?

Lynell Wilson- That is correct.

Mike Harper- So, we are under no obligation to house that agency. That should be a state expense.

Lynell Wilson- That is your determination.

Mike Harper - That determination is whether or not we offer them office space.

Lynell Wilson - Basically, what its stating in there is a general rule that the parishes aid the agencies in those parishes. It is up to y'all whether you support this agency or not.

Mike Harper - So that our only choice in your opinion is whether or not we support Beauregard Community Action.

Lynell Wilson-Yes sir.

Mike Harper- ok, thank you very much. We will review it. Ok at this point if we have no other questions.

Mrs. Winky - This Program has benefited a lot of people in this community and has done a lot of good. So why would you not want to do everything you could to support it any way that they could.

Mike Harper - We definitely have, we are currently paying the rent.

Mrs. Winky- Okay that is good. (inaudible)

Mike Harper - Well apparently, we have no say in that agency according to what we have just heard. So, you may go talk to them.

Mrs. Winky - This room should have been full of people who they have helped.

Wayne Reeves- They help people.

Mrs. Winky - And another thing, Sir, what was your name? I do not understand the security of doing this.

Lynell Wilson - No ma'am, let me explain something. When community services first came out, they wanted to change up the relationship with the federal Government and the local one, that is when the relationship with community services first started. The re-authorization of the community services block grant and the relationship with the block grant did not sever that relationship. It became the Federal Government, the State, and the Local. The state then became the one that decided who would serve any given parish with the services that they request. The Governor is the Chief Executive Officer of the state. He then

can identify a state agency to administer that grant. In this case, it is the Louisiana Work Force Commission, then from there they would choose the agencies that are serving these. So basically, in most instances, in those particular areas, it is the parish's support that help those agencies when they can. My hope is that you would support them and provide services if you can. Our hope is that you would continue to support them when you can, and service those individuals that it affects.

Mrs. Winky - Why do we keep getting moved from place to place to place? Why cannot we get a stationary place to be in this community and just keep it there? I understand that it has been moved to the Merryville area. That could be considered a hardship for some people. Whereas they could just come to the activities building easier. I understand that they are renovating and working on it.

Kelly Bailey- Mrs. Winky, I hope that we get this all ironed out because I commend you on your job. I know in my area you serve a lot of people, and for that I appreciate it.

Mrs. Winky- That is all I wanted to say.

Jeffery Meadows- Thank you.

Wayne Reeves- That is Parishwide that is not just one area, I know that in the past you have given statistics on different areas, and it is not just localized it is the whole parish, we have always worked with you guys.

Lynell Wilson - They do not actually report to the state the federal government the service provided, now if that is something that the parish would like to see they very well can share that with the parish annually, they do a thing every three years that is called a community needs assessment. That looks at the community and not just geographic, but community like the needs that they have in their community. They will be more than happy to share that information and give a little light on the situation.

Mike Harper - Yes, we would appreciate that, any other questions or comments?

Mrs. Winky - Do you want it broken down by areas? How do you want it?

Mike Harper- The areas are not important. I think it helps if people just have something that they can look at and see what benefits the agency is providing for Beauregard Parish. Maybe just some brief summary that you could share with the Police Jury. You may just be able to leave a copy here and they can review it as they are interested in it.

Mrs. Winky - I do not have one for this year. I do have one for the prior year.

Mike Harper- That would be fine. Thank you very much. Any other questions or comments?
