RESOLUTION 23-2021

A RESOLUTION AUTHORIZING ISSUANCE BY WATERWORKS DISTRICT NO. 3 OF BEAUREGARD PARISH, LOUISIANA, OF NOT EXCEEDING \$3,000,000 PRINCIPAL AMOUNT OF WATER REVENUE REFUNDING BONDS, SERIES 2021, MAKING APPLICATION TO THE STATE BOND COMMISSION, AND PROVIDING FOR OTHER MATTERS WITH RESPECT THERETO.

WHEREAS, on May 25, 2021, Waterworks District No. 3 of Beauregard Parish, Louisiana (the "Issuer") adopted a resolution authorizing the Issuer to proceed with refunding certain outstanding maturities of the Issuer's Water Revenue Bonds, Series 2012A dated January 25, 2012 on original issue, and its Taxable Water Revenue Bonds, Series 2013, dated April 3, 2013 on original issue (collectively, the "Refunded Bonds"), through issuance of not exceeding \$3,000,000 principal amount of its Water Revenue Refunding Bonds, Series 2021 (the "Bonds"); and

WHEREAS, the Beauregard Parish Police Jury (the "Police Jury"), the governing authority of the Parish of Beauregard, is the beneficiary of the Issuer, and therefore must approve its actions;

NOW, THEREFORE, BE IT RESOLVED by the Police Jury, the governing authority of the Parish of Beauregard, Louisiana, as follows:

<u>SECTION 1.</u> The statements of fact expressly contained within the preamble to this Resolution have been specifically reviewed by the Police Jury and are found to be factually true and correct, and are made resolutions of the Police Jury.

SECTION 2. The Police Jury does hereby approve and authorize the issuance, sale and delivery by the Issuer, of its Water Revenue Refunding Bonds, Series 2021, in the aggregate principal amount not exceeding \$3,000,000, to mature not later than January 1, 2034, at a rate or rates not exceeding 4.0% per annum, in accordance with the provisions of Subpart A of Part II, Chapter 4 of Subtitle II of Title 39 and Chapter 14-A of Title 39 of the Louisiana Revised Statutes of 1950, as amended (La. R.S. 39:501 et seq), all subject to the approval of the Louisiana State Bond Commission.

<u>SECTION 3.</u> The Secretary is empowered, authorized and requested to forward to the Louisiana State Bond Commission a certified copy of this resolution which shall constitute a formal application as herein provided.

SECTION 4. This resolution shall take effect immediately.

State of Louisiana, acting as the governing authority of the Parish of Beauregard, State of Louisiana, that:

SECTION 1. In compliance with the provisions of Article VI, Section 15 of the

Constitution of the State of Louisiana of 1974, and in accordance with the request of the Board of

Commissioners of Fire Protection District No. 4 of the Parish of Beauregard, State of Louisiana,

SECTION 5-52 PERMIT REQUIRED:

Except as provided for in Section 5-52, below, No owner or operator of an ambulance shall respond to any request for ambulance services originating within the parish without first obtaining a permit to operate an ambulance services, unless such request is made by a qualified emergency services provider, duly authorized to operating in Beauregard Parish.

SECTION 5-53 APPLICATION FOR PERMIT:

Except as provided for in Section 5-53, below, (4) Financial statements, for period of not less than two (2) years or in the case of an applicant for a permit who has not provided ambulance service for a minimum of two (2) years, financial statements and federal tax returns of the principles of such applicant for a period of not less than two (2) years. Audited financial statements shall be provided upon request.

SECTION 5-54 QUALIFICATION FOR PERMIT:

Except as provided for in Section 5-54, below, (a) (1) The probable performance and quality of the service offered by the applicant, to include among other things, proof of financial responsibility, the establishment and maintenance of a bona fide office in the parish from which services are offered withing thirty (30) days of acquiring a permit, and the ability of the applicant to provide both twenty-four (24) hour emergency and non-emergency response.

(a) (2) The experience that the applicant has had in the rendering of services.

SECTION 5-59 AMBULANCE SERVICE RESPONSE STANDARDS :

Except as provided for in Section 5-59, below, (h) The ambulance service found in excess of thresholds outline above in (a) can be fined per occurrence, according to the Beauregard Parish Police Jury Fee Schedule.

SECTION 5-63 QUALIFICATIONS OF DRIVERS:

Except as provided for in Section 5-63, All ambulance operators (drivers) must have current Driver's license in their possession at all times while operating an ambulance in Beauregard Parish.

SECTION 5-64 EMERGENCY MEDICAL TECHNICIANS:

Except as provided for in Section 5-64, Any person that is part of an ambulance crew must have a current medical certification which can be obtained through an internet search on the BEMS site.

SECTION 5-70 AMBULANCE SERVICE REVIEW COMMITTEE:

Except as provided for in Section 5-70, below,

The Committee will be made up of 10 members from the following services:

(a) OHSEP Director Chairperson: 1 member

- (b) Beauregard Parish Sheriff or designee:
- (c) Beauregard Fire Protection District Representatives:
- (d) Parish Jury Representatives: (Parish Administrator and 2 Police Jurors)
- (e) E911 Representative
- (f) City of DeRidder Representative

1 member 1 member from each District 3 members

1 member 1 member, non-voting advisory only

The Committee shall meet once a quarter or whenever called to meet by the chairperson. The committee shall do the following each year.

(d) March of each year, review all permitted ambulance company rates and submit the rates along with application for a permit to the Parish Police Jury.

(f) Whenever a new application is submitted for a permit after than in March, the committee shall review and make a recommendation to the Parish Police Jury withing 30 days of receiving the application for permit.

All other provisions of Ordinance 1-2019 not changed or modified by this amendment shall remain enforce and effect.

Discussion:

Scott Greenum stated that as of the morning of June 8,2021, MedExpress Ambulance Service, Inc. had met all the requirements of the Ordinance adopted by Jury in item number 1 above and that on behalf of the Ambulance Committee recommends that the Jury approve the permit application from MedExpress.

Kelly Bailey questioned the difference between the type of emergency care provided by Acadian Ambulance versus the type of emergency care that would be provided by MedExpress.

Jon Ried, spoke on behalf of MedExpress, and stated they would provide the same caliber of medical

expertise for emergency care that Acadian Ambulance is currently providing.

Scott Greenum stated that the Ambulance Committee has reviewed the ordinance in more detail and is working with Mr. Steve Landreneau to bring more amendments to the Jury for approval. However, under the newly amended ordinance, he recommended that MedExpress be granted their permit. They met all of the criteria for the permit and have paid the applicable fees.

Paul Fuseiler, spoke on behalf of Acadiana Ambulance, and that they caliber of emergency care provided by Acadian Ambulance is very different then MedExpress.

After discussion, Mike Harper asked if there was any further discussion. No one else spoke up. Eddie Ware seconded to approved the permit of MexExpress. No one opposed. Motion carried.
