The undersigned BIDDER proposes and agrees, if this Bid is accepted, to enter into an agreement with OWNER to furnish price quotes for specified materials as indicated in the Procurement Documents for the Bid Price and within the times indicated in this Bid and in accordance with the other terms and conditions of the Procurement Documents.
2. BIDDER accepts all of the terms and conditions of the Advertisement to Bid.
3. BIDDER must submit product data sheet (Sieve analysis) with bid, **along with a five-gallon sample of product.**
4. In submitting this Bid, BIDDER represents, as more fully set forth in the Agreement, that:
 - (a) BIDDER has examined and carefully studied the Bidding Documents and the following Addenda receipt of all which is hereby acknowledged: (list Addenda by Addendum Number and Date)

 - (b) BIDDER is familiar with and is satisfied as to all federal state and local Laws and Regulations that may affect cost, progress, performance and furnishing of the Materials.
 - (c) This Bid is genuine and not made in the interest of or on behalf of any undisclosed person, firm or corporation and is not submitted in conformity with any agreement or rules of any group, association, organization or corporation; BIDDER has not directly or indirectly induced or solicited any other Bidder to submit a false or sham Bid; BIDDER has not solicited or induced any person, firm or corporation to refrain from bidding; and BIDDER has not sought by collusion to obtain for itself any advantage over any other Bidder or over OWNER.

5. Bids will be evaluated and awarded on a TOTAL COST basis. The cost of transportation to the Beauregard Parish Road District barns will be considered. The Parish's

transportation cost of \$0.21 per ton mile will be added to the bids to determine the lowest bid. Separate bids for each road district barn will be considered.

7. The Owner reserves the right to reject any or all bids or to waive any informality in the bidding. The contract, if awarded, will be awarded to the low item bidder for each specified item.
8. The item to be bid is to be furnished to the Beauregard Parish Police Jury, for a period of one year from the date of opening of bid.
9. Each order under this contract will be placed by or through the Public Works Department of the Beauregard Parish Police Jury. A purchase order must be issued and received prior to accepting orders. No material is to be provided unless it has been cleared through the Public Works Department.
10. The Beauregard Parish Police Jury, in awarding this contract, does hereby agree to procure the item (s) as liked from the vendor to whom the contract is awarded during this twelve month period only.
11. Material ordered under this bid must be provided to the Police Jury within fifteen (15) days from the date order is placed.
12. . Unit Price Bid will be F.O.B. your plant. The unit price bid shall include all fees and costs required to furnish the materials included in the bid form.
13. In accordance with Act 1029 of the 1991 Regular Session of the Louisiana Legislature, NO State or Local Sales Taxes will be Applicable on the purchase of this material.

14. Preference for the purchase of Louisiana products shall be granted in accordance with LA Revised Statute 38:225.1, paragraph H which reads as follows:

H. Each procurement officer, purchasing agent, or similar official who procures or purchases materials, supplies, or equipment under the provisions of this Chapter may purchase materials, supplies, or equipment which are Louisiana products, as defined in Paragraph A (8) of this Section, and which are equal in quality to other materials, supplies or equipment, provided that all of the following conditions are met:

- (1) The cost of the Louisiana products does not exceed the cost of other materials, supplies, or equipment which are manufactured, processed, produced, or assembled outside the state by more than five percent.
- (2) The vendor of Louisiana products agrees to sell the products at the same price as the lowest bid offered on such products.
- (3) In cases where more than one bidder offers Louisiana products which are within five percent of the lowest bid, the bidder offering the lowest bid on Louisiana products is entitled to accept the price of the lowest bid made on such products."

15. Materials furnished shall be in accordance with the attached specifications.

16. Bidder agrees that if awarded the contract he/she will furnish an executed copy of the Affidavit for Attesting that Public Contract was not secured through employment or payment of solicitor.

SPECIFICATIONS FOR
3X5 Limestone**

- 1.01 This specification is intended to provide dense gray crushed limestone for use on parish roads as specified in DOTD 2016 Standard Specifications for Roads and Bridges. Crushed limestone shall consist of fragments of hard, durable particles of stone showing an abrasion loss of not more than forty-five (45) percent, containing not more than five (5) percent soft fragile material, and shall be 2.5 or less. When tested by Louisiana DOTD designation; TR113, the material shall conform to the following gradation requirements:

U S SEIVE	% RETAINED
5"	0
4"	0-20
3"	30-60
2"	80-100
1"	90-100
1/2 "	95-100

- 1.02 Quality Control of Material shall be supported by a certification from the supplier that material as provided under this specification complies with the gradation as indicated. This certification (Sieve Analysis) must be provided with the bid and when requested, a minimum every 2,000 tons received.
- 1.03 Delivery of materials shall be made only at which time as a delivery scale ticket shall be provided the parish representative. The delivery ticket will indicate date, contractor, truck license number, and representative of the parish who certifies that material in the quantity indicated on the ticket was actually made to the point indicated on the delivery order.
- 1.04 Measurement and payments shall be made by the tons of unit price.
