It is understood and agreed that the following alterations, changes and/or omissions shall be made in the Plans and the Specifications, as now drawn and written, and that such alterations, changes and/or omissions shall be incorporated in the project during construction. Unless such an alteration, change and/or omission is specifically mentioned in this addendum, the plans and specifications as now drawn and written, shall govern in all respects.

Acknowledge receipt of this Addendum on the Bid Form.

Bidders are advised to call attention of all sub-bidders and suppliers to all information and changes which may affect their work.

This addendum consists of a total of 2 pages.

PART 1 - Drawing Modifications

- 1. A2.1-1: Door 104A to be removed from the project in its entirety.
- 2. A2.1-1: Provide (2) exterior hose bibbs at opposite ends of the building.
- 3. A2.3-Door Schedule: Doors may be 6'-8" in lieu of 7'-0" as shown. Doors shall remain compliant with current Federal ADAAG.
- 4. A6.1-2: Lighting in building to be modular building mfr standard LED fixtures with light levels to meet IES and NEC standards.

- A6.1-2: Ceiling systems may be 2x2 suspended ceiling systems in lieu of as shown. Insulation for suspended ceiling system option shall be installed between roof deck and roofing system. Insulation over suspended ceiling system is not allowed.
- 6. A3.1 2/3: Exterior doors to be steel doors in steel frames.
- 7. A1.1-1: Gravel parking to be roughly 78'-0" in lieu of 97'-0" as indicated on plans.
- 8. E1.1-1: Provide minimum (1) gfi 20A duplex outlet with WP cover on each exterior elevation of the building.

PART 2- Specification Modifications

- 1. Advertisement for Bids: Date and time to received bids has not changed. It remains Thursday, March 02, 2023 at 3:30pm.
- 2. 133423.13-2.2.B.10: Building shall have mechanical a/c and heat system to heat and cool all rooms to comply with IMC 2015. Coordinate with electrical. Restrooms shall have mechanical ventilation per IPC 2015 and IMC 2105.
- 3. 133423.13-2.2.B.4.a: Door hardware shall be series 4000, Grade 2 performance levels.
- 4. 133423.13-2.2.B.4: Exterior doors shall be 20 ga insulated steel doors.
- 5. 133423.13-2.2.B.4: Interior doors to be 3-ply heavy duty with oak faces.

Contractor shall note that prior approval is by manufacturer's name only.
