#### Ordinance No. 03-2023

An Ordinance to amend Ordinance No. 02-2022 and to amend Ordinance No. 02-2023 to geographically merge precincts and establish polling locations for Beauregard Parish.

AN ORDINANCE TO GEOGRAPHICALLY MERGE PRECINCTS AND ESTABLISH POLLING LOCATIONS FOR BEAUREGARD PARISH

**WHEREAS,** by adoption of Ordinance 02-2022, the Parish Governing Authority adopted a redistricting plan for use beginning with the regular elections in the Fall of 2023; and

**WHEREAS,** to accomplish the redistricting the Parish Governing Authority had to create additional precincts, which was accomplished in Ordinance 02-2022; and

WHEREAS, in order to make the election process in the Parish more efficient, the Parish Governing Authority seeks to geographically merge precincts, to the extent that is practical and authorized by Louisiana law; and

**WHEREAS,** to the Parish Governing Authority geographically merged several precincts by the adoption of Ordinance 03-2023, and will now geographically merge additional precincts prior to qualification for the 2023 Fall Election,

WHEREAS, the Parish Governing Authority is required to provide descriptions of each geographically merged precinct, to the extent that is practical and as authorized by Louisiana law; and

WHEREAS, the Parish Governing Authority must assign polling locations to each of the precincts created.

**THEREFORE BE IT ORDAINED,** by the Parish Governing Authority, State of Louisiana, that the Governing Authority, hereby geographically merges the precincts set forth in Attachment A.

**BE IT FURTHER ORDAINED,** that the Governing Authority hereby restates the written descriptions and assigns polling locations for the effected precincts set forth in Attachment B.

**BE IT FURTHER ORDAINED,** that the digital shape files of the precincts submitted to the Secretary of State shall serve as the formal representation thereof, with the written descriptions contained herein being merely descriptions thereof.

**BE IT FINALLY ORDAINED,** that the precincts as set forth in the Attachments hereto, shall first take effect, for all purposes, with respect to the regularly scheduled elections in the Fall of 2023.

### 1. Merge Precincts 7A and 7C with Precinct 30 into Precinct 30

### Maintains the current polling location of Precinct 30

Beginning at the intersection of the Beauregard Parish boundary and an unnamed road located near the coordinates (-93.386741, 30.882446), then south along the unnamed road to its intersection with an unnamed railway near (-93.386648, 30.239206), thence south on the railway to its intersection with Graybow Rd, then southwest on Graybow Rd to its intersection with Pujo Rd, then south on Pujo Rd to its intersection with Neale Oilfield Rd, then east on Neale Oilfield Rd to its intersection with Parish Rd 457, then south on PR 457 to its intersection with State Route 27, then east on SR 27 to its intersection with Cowpen Creek, then northeast along the creek to its intersection with Pine Ridge Rd, then north on Pine Ridge Rd to its intersection with Graybow Rd, then east on Graybow Rd to its intersection with unnamed stream 259 feet northeast of Ward Line Rd, thence south on the stream to its intersection with Cowpen Creek, thence northerly on the creek to its intersection with Pine Ridge Rd, thence north on Pine Ridge Rd to its intersection with Graybow Rd, thence northeast on Graybow Rd to its intersection with West Palmetto Creek, thence northwest and north along the creek to its intersection with a drainage canal located near the coordinates (-93.319345, 30.836673), thence north, east and north along the canal to its intersection with S Planer Mill Rd, thence north on S Planer Mill Rd to its intersection with Planer Mill Rd, thence north on Planer Mill Rd to its intersection with Massey Rd, thence west on Massey Rd to its intersection with Wingate Rd, thence north on Wingate Rd to its intersection with Glendale Rd, thence west on Glendale Rd to its intersection with State Route 3225, thence north on SR 3226 to the Beauregard Parish boundary, then west on the boundary to the point of beginning

### 2. Merge Precinct 11A with Precinct 11B into Precinct 11B

### Maintains the current consolidated polling location with Precinct 11

Beginning at the intersection of Beauregard Parish boundary and Camp Edgewood Rd, thence southeast on Camp Edgewood Rd to its intersection with Pilgrim Rest Rd, thence north on Pilgrim Rest Rd to its intersection with Missouri Pacific Railway, thence northeast on the railway to its intersection with Cowpen Creek, thence north on the creek to its intersection with State Route 12, thence northeast on SR 12 to its intersection with Clark Rd, then north on Clark Rd to its intersection with Susie Alston Rd, then east on Susie Alston Rd to its intersection with Dru Rd, then north on Dru Rd to its intersection with Cole Creek, then southerly along the creek to its intersection with Hickory Branch, thence south on Hickory Branch to its intersection with Beauregard Parish boundary, thence west and north on the boundary to its intersection with the point of beginning

## 3. Merge Precinct 12A with Precinct 12B into Precinct 12A

# Maintains the current consolidated polling location of Precinct 12A

Beginning at the intersection the Beauregard parish boundary and Righthand Creek, then west on the creek to its intersection with a tributary of Righthand Creek near the coordinates (-93.131774, 30.567560), then northwest along the tributary to its intersection with an unnamed road near the coordinates (-93.137645, 30.575152), then west on the road to its intersection with Louis Burnett Rd, then north on Louis Burnett Rd to its intersection with a tributary of Hurricane Creek near the coordinates (-93.142457, 30.592450), then south on the tributary to its intersection with Hurricane Creek, then southerly on the creek to its intersection with Barnes Creek, then northwest on the creek to its intersection with Smith Gully, then west and northwest on Smith Gully to its intersection with a tributary of Smith Gully near the coordinates (-93.192164, 30.584711), then southwest on the tributary to its intersection with an unnamed road near the coordinates (-93.200821, 30.578077), then south and west along the road to its intersection with an unnamed road near the coordinates (-93.215236, 30.565522), then north and west along the road to its intersection with US Hwy 171 then south on US Hwy 171, to its intersection with Gaytine Rd, then east and then north on Gaytine Rd to its intersection with Ernest Broussard Rd, then continue north on Ernest Broussard Rd and its extension to its intersection with Foreman Rd, then east and south on Foreman Rd to its intersection with Fawn Trail, thence east on Fawn Trail for .467 miles to its intersection with a branch of Boggy Creek, thence northeast on the branch to its intersection with Boggy Creek, thence east and southeast on the creek to its intersection with the Beauregard Parish boundary, thence north on the boundary to the point of beginning.

### 4. Merge Precinct 16A with Precinct 16C into Precinct 16A

# Maintains the current polling location of Precinct 16A

Beginning at the intersection of US Hwy 171 and Lee Nichols Rd, then west on Lee Nichols Rd to its intersection with Butler Rd, then south on Butler Rd to its intersection with Crosby Rd, the west on Crosby Rd to its intersection with Morris Rd, then south on Morris Rd to its intersection with Pleasant Hill Rd, then east on Pleasant Hill Rd to its intersection with Franklin Rd, then southeast on Franklin Rd to its intersection with Granberry Rd, then west on Granberry Rd to its intersection with Jack Hines Rd, then south on Jack Hines Rd for 0.5 miles to its intersection with a fence line, then west on the fence line for 1.92 miles to its intersection with an unnamed railway, then south on the railway to its intersection with Barnes Creek, then southerly on the creek to its intersection with Granger Rd, then south on Granger Rd to its intersection with S Mennonite Rd, then east, north and east on S Mennonite Rd to its intersection with US Hwy 171, then north on US Hwy 171 to the point of beginning.

# 5. Merge Precinct 16D with Precinct 16 into Precinct 16

### Maintains the current polling location of Precinct 16

Beginning at the intersection of US Hwy 171 and State Route 26, then southeast on SR 26 to its intersection with Deer Creek, then south along the creek to its intersection with State Route 394, then west on SR 394 to its intersection with Griffin Rd, then south on Griffin Rd to its intersection with Lumas Rd, then west on Lumas Rd to its intersection with US Hwy 171, then north on US Hwy 171 to the point of beginning.

# 6. Merge Precinct 25A with Precinct 25 into Precinct 25

# Maintains the current polling location of Precinct 25

Beginning at the intersection of N. Pine St and Hwy 90, then west on Hwy 90 to its intersection with Ellis Rd, then north on Ellis Rd to its intersection with Glendale Rd, then west on Glendale Rd to its intersection with Planer Mill Rd, then north on Planer Mill Rd for .25 miles to its intersection with a railway line, then easterly along the railway to its intersection with Hickory Branch, then north along the branch for 300 feet to its intersection with a tributary of Hickory Branch, then northeast along the tributary to its intersection with Logan St, then east on Logan St to its intersection with N Pine St, then south on N Pine St to its intersection with Harrison St, then east on Harrison St to its intersection with Ampacet Dr, then south on Ampacet Dr to its intersection with LC Lee Rd, then west on LC Lee Rd to its intersection with a railway, then south along the railway to its intersection with Hickory Branch, then northwest along the south on N Pine St to its intersection with a railway, then south along the railway to its intersection with Hickory Branch N Pine St, then west on LC Lee Rd to its intersection with a railway, then south along the railway to its intersection with Hickory Branch, then northwest along the branch to its intersection with N. Pine St, then south on N Pine St to the point of beginning.

### 7. Merge Precinct 26A with Precinct 26 into Precinct 26

# Maintains the current polling location of Precinct 26

Beginning at the intersection of the Beauregard Parish boundary and N Pine St, then south on N Pine St to its intersection with Harrison St, then east on Harrison St to its intersection with Ampacet Dr, then south on Ampacet Dr to its intersection with LC Lee Rd, then west on LC Lee Rd to its intersection with a railway, then south along the railway to its intersection with Hickory Branch, then northwest along the branch to its intersection with N. Pine St, then south on N Pine S to its intersection with Hwy 90 (E 1<sup>st</sup> St), then east on Hwy 90 to its intersection with Jackie Robinson St, then north on Jackie Robinson St and its extension to its intersection with an extension of Cook Dr, then east on the extension to its intersection with a tributary of Flat Creek, then northeast on the tributary to its intersection with Flat Creek, then northwest along the creek to its intersection with Countyline Rd, then north on Countyline Rd to its intersection with the Beauregard Parish boundary, then east on the boundary to the point of beginning.
