- 8. The Beauregard Parish Police Jury, in awarding this contract, does hereby agree to procure the item(s) as liked from the vendor to whom the contract is awarded during this six month period.
- 9. Material ordered under this bid must be provided to the Police Jury within one (1) week from the date order is placed.
- 10. Total Bid Price will be F.O.B. Destination. The Total Bid Price shall include all fees and costs required to furnish the materials included in the bid form.
- 11. In accordance with Act 1029 of the 1991 Regular Session of the Louisiana Legislature, No State or Local Sales Taxes will be Applicable on the purchase of this material.
- 12. Preference for the purchase of Louisiana products shall be granted in accordance with LA Revised Statute 3 8:225 1, paragraph H which reads as follows:
  - "H. Each procurement officer, purchasing agent, or similar official who procures or purchases materials, supplies, or equipment under the provisions of this Chapter may purchase materials, supplies, or equipment which are Louisiana products, as defined in Paragraph A (8) of this Section, and which are equal in quality to other materials, supplies or equipment, provided that all of the following conditions are met:
  - (1) The cost of the Louisiana products does not exceed the cost of other materials, supplies, or equipment which are manufactured, processed, produced, or assembled outside the state by more than ten percent.
  - (2) The vendor of Louisiana products agrees to sell the products at the same price as the lowest bid offered on such products.
  - (3) In cases where more than one bidder offers Louisiana products which are within ten percent of the lowest bid, the bidder offering the lowest bid on Louisiana products is entitled to accept the price of the lowest bid made on such products.

# BEAUREGARD PARISH POLICE JURY SPECIFICATIONS

#### 1.0 ASPHALT

- 1.1 Asphalt shall be prepared by the refining of petroleum Asphalt shall be uniform in character, free from water, and shall not foam when heated to 3500F (I 77"C). Asphalt shall be from an approved source listed in QPL 4 1.
- 1.2 Refinery or supplier storage tanks, piping, retorts, booster tanks, and other equipment used in delivering, storing or handling asphaltic materials shall be kept clean and in good operating condition and shall be operated as to avoid contamination of the contents with foreign materials.
- 1.3 Final test results for asphalt materials will be applied to the proper table in this Section for conformance to specifications. Any deviation from the specifications will result in a payment adjustment as specified.
- 1.4 Samples taken at the refinery or supplier shall comply with specification requirements. When the refinery or supplier sample fails to meet these requirements, the material will be rejected and shall not be shipped to the jobsite.
- 1.5 When asphalt materials sampled at the point of delivery do not comply with requirements for I 00 percent pay, and in the opinion of the engineer have resulted in an unsatisfactory product, the materials shall be removed and replaced or otherwise corrected at no direct pay. The adjustment in pay for asphalt materials shall be applied only to samples taken at the point of delivery. When test results are such that a payment adjustment would result from more than one test value, the payment adjustment for the greatest reduction shall apply.

### 2.0 ASPHALT MATERIAL ADDITIVES

- 2.1 ANTI-STRIP: Anti-strip additives for asphalt materials shall be approved products listed in QPL 57.
- 2.2 SILICONE: Silicone additives for asphalt materials shall be approved products listed in QPL 22.
- 2.3 POLYMERS: Polymer modified asphalt materials shall be approved products listed in QPL 4 1. Polymer additives shall be pre-blended with the asphalt material. In-Ene blending will not be allowed.

- 3.1 This specification is intended to provide Cationic Emulsified Asphalt (CRS-2) for use on parish roads.
- 3.2 Quality control of materials shall be supported by a certification from the supplier, that material as provided under this bid complies with the specifications, as indicated, when requested.
- 3.3 Delivery of materials shall be made only after being contacted by a representative of the parish and to the roads or Parish Maintenance Yard indicated. The delivery ticket will indicate date, supplier, truck license number, and representative of the parish who certifies that material in the quantity indicated on the ticket was actually made to the point indicated on the delivery order.
- 3.4 Measurements and payment shall be made by the gallon unit price.

# 4.0 ANIONIC EMULSIFIED ASPHALT (SS-1H):

- 4.1 This specification is intended to provide Anionic Emulsified Asphalt (SS-1) for use on parish roads.
- 4.2 Quality control of materials shall be supported by a certification from the supplier, that material as provided under this bid complies with the specifications, as indicated, when requested.
- 4.3 Delivery of materials shall be made only after being contacted by a representative of the parish and to the roads or Parish Maintenance Yard indicated. The delivery ticket will indicate date, supplier, truck license number, and representative of the parish who certifies that material in the quantity indicated on the ticket was actually made to the point indicated on the delivery order.
- 4.4 Measurements and payment shall be made by the gallon unit price.
