This project focuses on retrofitting the second floor with thirty-two workstations, printers, scanning and fax capabilities, fully equipped conference rooms and the requisite server capacity. The ETE Center will also serve as a communication hub for first responders in the event of weather or other economic impacts. The Beauregard Parish Police Jury will be responsible for \$3,250,540.45 up front with reimbursement to follow upon submittal. The Parish twenty-five percent match responsibility will be \$650,108.09. The Parish will be responsible for all maintenance and upkeep of the facility, equipment, and services. After ten years of operation the ETE Center will be diverted back to the Beauregard Parish Police Jury.
 - B. Proceed with request to allocate FEMA funding to complete the second floor to house the District Attorney's office and staff, with the addition of the parking lot located by the Gothic Jail. The parking lot would serve as overflow parking for the Activities Building, Courthouse, and the Gothic Jail. The Parish cost share of this work will be ten percent. Consideration of completing the first floor for utilization as a smaller ETE Center or for other entities would be at a later date.
10. Discussion of request to increase the Parish Hotel/Motel Tax from four percent to six percent, with the additional two percent to be used for the operation and maintenance of the Beauregard Covered Arena

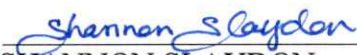

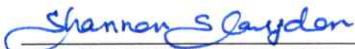
