**Announcement of Public Meeting**

Notice is hereby given that at its meeting to be held on Tuesday, March 24, 2026 at 4:00 p.m. at its regular meeting place, the Police Jury Administration Building, 201 W. 2nd Street, DeRidder, Louisiana, the Police Jury of the Parish of Beauregard, State of Louisiana, plans to consider adopting a resolution ordering and calling an election to be held in Sales Tax District No. 1 of the Parish of Beauregard, Louisiana to authorize the levy of a sales and use tax therein.

4. **Discussion and approval of 2026 Road List**

A motion to approve the amended list was made by Elizabeth Montgomery and seconded by Michael Harper. No opposition. Motion carried.

5. **Discussion and approval of the updated 2026 Multi-Jurisdictional Hazard Mitigation Plan**

A motion to approve was made by Michael Harper and seconded by Ernest Dickerson, Jr. No one opposed it. Motion carried.

6. **Discussion and approval of the Parish Health Insurance agent of record**

A motion to retain the current agent, Jason Weinland was made by Michael Harper. Elizabeth Montgomery, Doug Hillebrandt, and Jerry Shirley opposed. Jeffery Meadows and Ernest Dickerson, Jr. also voted to retain Jason Weinland. Parish President Eddie Ware broke the tie

by casting a vote to retain Jason Weinland. Motion carried to retain the current agent, Jason Weinland, with a 4 – 3 vote.

**7. Discussion and approval for the Parish to enter into a subordination or similar agreement with Beauregard Federal Savings Bank related to construction of a building on property leased by Davis Timber Company, Inc., from the Beauregard Regional Airport**

A motion to approve was made by Jerry Shirley and there was no second. Motion failed.

**8. Discussion and approval to enter into a Cooperative Endeavor Agreement with the Greater Beauregard Chamber of Commerce for payment of \$400.00 per approved Request for Proposal as approved at the November 12, 2025, meeting**

Motion was made by Michael Harper to maintain the current CEA for 1 year and only change the amount. The motion was seconded by Elizabeth Montgomery. No one opposed it. Motion carried.

**9. Discussion and approval to amend the Cooperative Endeavor Agreement with CrossTies Freedom Ministries to reflect the two 2026 payments of \$20,000 each from the Louisiana Opioid Abatement Task Force Settlement Funds**
