### Coronavirus Disease 2019 (COVID-19) Beauregard Parish Police Jury Mitigation Strategy

**Beauregard Parish, Louisiana** – In an effort to reduce and limit the spread of COVID-19, Federal and State Governments have announced emergency procedures. Providing uninterrupted service to our citizens while preserving their health and safety is a primary goal of the Beauregard Parish Police Jury. Achieving this goal is possible by implementing and following strategies designed to reduce the spread of a new virus within a community. Community mitigation strategies are a set of actions that local governments, communities and individuals can take to help slow the spread of respiratory virus infections like COVID-19.

Police Jury offices will remain open to serve the citizens of Beauregard Parish. Our staff has been instructed to perform regular health checks, including temperature and respiratory symptom screening. During this time, we require from our staff a strict policy to “stay home if you are sick or if a sick family member is in your home.”

Our mitigation actions also include minimizing close contact between our staff, and our staff and citizens. If you have a fever, cough, or shortness of breath, we encourage the use of our website, phone calls and emails to conduct parish business. Although our administrative office will remain open, public access will be limited to a controlled portion of our lobby. At that location, citizens will have access to resources, may provide written service requests and interact with our staff in a manner consistent with social-distancing measures. We request that our citizens use widely circulated and common-sense personal hygiene procedures; and, use the resourced below if they exhibit symptoms consistent with COVID-19.
